What is the Difference Between Mediation and Facilitation?

Mediation is a consensual process in which an impartial third person(s) assists two or more parties to reach a voluntary agreement which resolves a dispute or provides options for the future. The Santa Lucia Group mediators help the parties identify their individual needs and interests, clarify their differences, and find common ground. A few points to keep in mind:

- The parties are the decision makers; the mediators do not render a decision.
- The parties determine the issues that need to be addressed; the mediators guide the process, help the parties discuss the issues and maintain a safe environment.
- The mediators do not give advice to the parties, legal or otherwise. However, in some instances, the mediators may help the parties generate options for the parties to evaluate, possibly with the advice and assistance of another professional.
- The process is usually confidential, with any exceptions disclosed and discussed prior to beginning a mediation.
- The success of mediation rests largely on the willingness of the parties to work at understanding each other and to seek solutions that meet each other's needs.
